RISING TO DIGNITY AWARD

Message from the Hon'ble Prime Minister

Mahatma Gandhi, Father of our great nation, had an enduring concern for people affected with leprosy. His vision was not to treat them but also to mainstream them in our society.

Our efforts to eliminate leprosy from this country, under the National Leprosy Eradication Program is just a tribute to his vision. This Program was launched back in 1955, the goal of leprosy elimination as a public health problem, that is, prevalence rate of less than 1 case per 10,000 population at national level was achieved in 2005.

Although, the case detection rate thereafter has marginally decreased, visible deformity at the time of diagnosis has increased. This suggests that cases are being detected late. As a country, we have to leave no stone unturned to not just reach the last mile, but also work together, to eliminate the social stigma attached with this disease. A three-pronged strategy for early detection of leprosy cases in the community was introduced in 2016, under the National Health Mission, especially in hard to reach areas.

A special leprosy case detection campaign was carried out in 2016, as a result of which more than 34,000 cases were confirmed and were put on treatment. In addition, persons who are in close contact with the patients were also given medicines to reduce the chances of leprosy occurrence among them.

Although, we have achieved our target at the national level, we have long arduous way to go to ensure that this treatable disease is eliminated from our country. We also have to work together for the socio-economic upliftment of the cured persons and their contribution in nation building. We have to strive hard to ensure that these citizens of our country lead a life of dignity that Mahatma Gandhi dreamed of. In this context, I am happy to note the work being done by The Nippon Foundation, which is organizing the launch of Global Appeal 2017 to end stigma and discrimination against people affected by leprosy.

Context of Our Operations

India declared itself as having eliminated leprosy as a public health concern in 2005, when it brought down the prevalence of leprosy to less than one new case per 10,000 population. This benchmark set by WHO, indicated a level of prevalence at which the disease ceases to be a public health concern. Compared to the prevalence rate of nearly 50 per 10,000 at the time of Independence, this was indeed a laudable achievement.

Mr. Yohei Sasakawa, Chairman of The Nippon Foundation, who has been instrumental in bringing global attention to leprosy eradication, realised that his mission to eliminate leprosy would be incomplete without eradication of the social stigma associated with the disease.

Mr. Sasakawa compares the fight against leprosy to the two wheels of a motorcycle. The front wheel being the medical and the rear being the socioeconomic development of leprosy-affected persons. After decades of active support to medical treatment and care, he initiated two visionary Programs to ensure the social and economic integration of leprosy affected people.

As a first step, he set up the **National Forum of Leprosy Affected People (now renamed 'Association of Persons Affected by Leprosy') in 2005** – an association of leprosy-affected people living in colonies across the country. The purpose of this organization was to give voice to leprosy-affected people and to enable them to lead their struggle for inclusion and acceptance.

As a second step, he established **Sasakawa-India Leprosy Foundation** (S-ILF) in November 2006 to provide socio-economic empowerment opportunities to leprosy-affected people and their families, especially those living in leprosy colonies.

About S-ILF

VISION

To work for the integration of leprosy cured people and their families into society by ending the discrimination faced by them.

MISSION

Instituted in November 2006, Sasakawa-India Leprosy Foundation (S-ILF) works for main streaming persons affected by leprosy and their families through their social-and economic empowerment as well for increasing their social acceptability. It promotes change in social attitudes and behaviours by spreading the facts about leprosy and demonstrating that the disease is full curable and leprosy-affected people are just like anyone else. S-ILF envisages a society in which leprosy cured persons no longer need to have the demeaning dependence on alms or begging and can live their lives with dignity.

To end the stigma against the disease and to ensure equal social, economic and cultural opportunities for those affected by leprosy.

Goals:

- To create conditions that will enable them to have equal access to economic opportunities.
- To increase social acceptability of leprosy cured people and their families through dissemination of scientific information.

Who do we work with?

We work with leprosy-affected people living in self-settled colonies who are members of the Association of People Affected by Leprosy (APAL). There are approximately 800 colonies that are scattered across India, with some areas having larger number of colonies than others. While some colonies were set up by the government or by missionaries, most of them are settlements that came up spontaneously on public land. These colonies are usually found near erstwhile leprosy hospitals, on banks of rivers, near drains, in and near religious places or places of tourist attraction.

Our Program Goals

Reintegration of leprosy-affected people into mainstream society requires both i) enhancing the capabilities of those affected to access market opportunities and ii) changing mindsets and attitudes of the others.

S-ILF has adopted a five-pronged approach to achieve this:

S-ILF's programs, which place leprosyaffected people and their families at the core of development, reflect S-ILF's inclusive and integrated approach. S-ILF recognizes that poverty, education, financial independence and dignity are all inter-connected and are impacted by the underlying stigma associated with the disease.

Message from Our Patron

Sasakawa-India Leprosy Foundation (S-ILF) was established to help leprosy-affected people and their families participate more fully in society through social and economic assistance and support. Providing livelihood support and education as well as ensuring a life of dignity have been its major areas of work.

Mr. Tarun Das, former head of CII, has recently taken over as Chairman of the Board of Trustees. leprosy-affected people and to make India leprosy free in the near future - free of the diseases and free of the stigma against the people affected by it.

Through the expansion of livelihood and skill training programs, I believe we will see further social and economic participation by person affected by leprosy and their children, enabling them to support themselves and live with dignity, free from fear of discrimination.

Message from the Executive Director

It is now 10 years since S-ILF came into being. We at S-ILF are proud of our achievements but equally conscious of the huge amount of work that remains to done. We have been able to get here with inspiration from Mr. Sasakawa, the vision, direction and support of an engaged Board and a dedicated and committed team.

S-ILF marked its 10th anniversary by launching a film, which shows the enormous transformation in the lives of those affected and their families when they get access to financial and educational resources. It is a film of hope and urges the viewers to join us in our work in whichever way they can.

The highlight of the year for us was a message from the Prime Minister at the launch of a Global Appeal to end Discrimination where he appealed for ending of stigma and discrimination and creating a leprosy free India. The Minister of Social Justice and Empowerment, giving away our Rising to Dignity awards, too spoke strongly of the need for inclusion and engagement.

Our program of empowerment workshops brought us some heart-warming results. These were developed as a platform for training leprosy-affected people to identify their needs and write petitions for inclusion in appropriate government welfare schemes. We also facilitated them to reach out to their MPs and MLAs. In West Bengal, a colony was identified as an Adarsh Colony and government efforts are being directed to provide it the infrastructure and facilities commensurate with this ideal; in Karnataka, efforts of leprosy-affected people have resulted in land "pattas" being given to them, thereby removing the constant threat of eviction.

It was also an important year for us as we engaged and interacted among ourselves, our Board and other experts to develop a new five-year strategy for S-ILF. Under this new initiative, we plan to not only scale up our flagship programs but to also get more deeply engaged in policy advocacy. We are fortunate to be working with an informal Forum of Parliamentarians. Led by Mr. Dinesh Trivedi, this forum cuts across party lines and has members who are deeply committed to creating a Leprosy Free India.

This year also saw a change in the Board as Dr. Noordeen stepped down after leading the foundation for a decade. Mr. Das taken over as the new Chair of the Board of Trustees. Under his leadership and with support from our Board, we are aiming to do our bit to ensure that India becomes leprosy free in the near future. This will require a collective effort and we look forward to forging new partnerships and engagements with a wide range of stakeholders across the different sections of society in the coming years.






Livelihood Program

Leprosy-affected families living in isolation are usually dependent on donations and begging for their survival. S-ILF provides them financial assistance in the form of small grants for setting up micro enterprises. To ensure sustainability of these initiatives, S-ILF encourages ownership by asking people to identify the enterprises themselves. It focuses on providing training in entrepreneurship and livelihoods, skills and capacity building.

Process

S-ILF works in close coordination with the Association for People Affected by Leprosy (APAL). In addition to providing financial resources, S-ILF actively facilitates each grantee to take more informed decisions. It provides them support at all stages of project activities i.e., from its identification to implementation and monitoring. It also takes the help of local NGOs called 'Mentors', to assist the beneficiaries in implementing the projects and to provide them guidance from time to time to meet the challenges.

Capacity building through trainings, workshops and exposure visits is essential to ensure the longterm sustainability of the micro-enterprises. S-ILF's aim is to strengthen the technical expertise and morale of the grantees so that they can sustain their business enterprises on their own.



S-ILF's Outreach: 2191 direct beneficiaries, 208 Colonies in 113 districts from 18 States


S-ILF achieves this through micro-enterprise development training, business orientation workshops, enterprise formulation, book keeping, customized training, regular guidance through mentorship and close monitoring.

In its projects, financial assistance is transferred directly into bank accounts thereby cutting off all intermediaries and encouraging banking practices. Funding is staggered and disbursement is based on achievement of milestones. Together with active participation of mentors and the beneficiaries, S-ILF is deeply involved in inculcating a dignified sense of ownership and accountability among the beneficiaries.



Livelihood Projects Statewise (2008-17)






Youth Entrepreneurship Program

Very often young people, are afraid of social stigma. They do not want to leave their colonies to seek work outside. Instead, they are keen to start their own small enterprises and become self-reliant.

Earlier attempts to integrate them in S-ILF's livelihood projects failed largely because of differences in age and perceptions between the youth and older beneficiaries. In response, S-ILF has developed a Youth Entrepreneurship Program. Under this program, youth from colonies are trained to identify and manage small business for which funding is provided by S-ILF.

In 2016-17, 20 youth from 3 states Gujarat (Junagadh District), Madhya Pradesh (Indore & Ujjain District), Maharashtra (Amravati & Ahmednagar Districts) were invited to attend a five-day residential training on microenterprise proposal in Vadodara. Out of these, 18 youth submitted project proposals and 17 got selected for funding.

We had worked as labour in construction sites. We had the work experience but lacked business techniques like market research, budget, planning for business etc. We learnt about these in the training provided by S-ILF. We will put our learning into practice in our business.

It was our first experience to work with S-ILF. We received training and subsequently we developed a project on Mandap Decoration. In the beginning, we faced many challenges since none of us knew anything other than begging, but S-ILF always guided us to earn our living with dignity. We took financial support of Rs. 2,75,000 to start our activity and today we have created assets worth of Rs. 7 lakhs. People from outside our colony is also working in our project, thanks to S-ILF we have found a regular income source.

In this three days training, I got to know the deep insight of market, market research, preparation of business plan by the beneficiaries, SWOT analysis and its use in making group decision, Identification of stakeholders and their roles, marketing skills, regular maintenance of day to days' activities.

Earlier we submitted a proposal for brick making, and it was approved but since we could not get license so we could not initiate our project. Then we assessed again and decided to start tent house (DJ, sound system & utensils etc.) project and submitted another proposal. Now 7 of us are working together and have distributed our work as per our aptitude. Over the last one year, we are getting a good response. We have reinvested our profit in building our assets so that we are able to cater to all the orders. Now we are in need of a laptop to maintain our records. None of us are engaged in begging since we started this activity.

Education Program

Unfortunately, children of leprosy-affected families also face discrimination and exclusion even though they themselves do not have leprosy. Although their parents see education as a necessary means for social and economic betterment, they are often too poor to send their children to good schools.

Usually the children go to Government schools where teaching is poor and discrimination by the teachers is rampant. Dropout rates are quite high and students give up after 7th or 10th grade. Even among those who complete grade 12, few are inclined to go for higher studies and tend to look for petty jobs. Others, who are interested in studies, do not have the economic means to pursue the courses.

Skills to Employment Program (STEP-UP)

There is a strong need for vocational training among youth. Recognizing this, S-ILF launched Skills to Employment Program (STEP UP). Under this program, S-ILF provides scholarships for skills training and education that would make them easily employable and financially independent. S-ILF has successfully collaborated with the National Skill Development Corporation (NSDC) to conduct a skill development program and has trained 585 youth for entry level jobs.

The unique characteristics of this program are i) that the training is provided free of cost, and ii) 60-70% of the youth who successfully complete their training are guaranteed jobs. S-ILF does this with the help of the training partners.

Nursing Scholarships

S-ILF's Nursing scholarship program was initiated to meet a strong desire expressed by girls from leprosy-affected colonies to become nurses. These girls felt that this would enable them to look after their family and community. Girls from leprosy colonies usually drop out after completing high school due to shortage of funds. S-ILF's Nursing Scholarship Program bridges the gap between their circumstances and their aspirations to become dignified, responsible and financially independent women.

A skill development class in Odisha

Starting with a batch of 5 girls, now S-ILF has increased the number of scholarships to 10 in a year. Since 2011, S-ILF provided the scholarships to 55 girls. Of these, the first batch has graduated and all girls have found well-paying jobs. Four of them are working with hospitals in Maharashtra, Delhi, Dehradun and one is placed as a Nurse Mentor at the Community Health Centre (CHC) in Shravasti, UP.

S-ILF is running its sixth batch of nursing scholars.

His Holiness Dalai Lama - Sasakawa Scholarship Program

For most students from leprosy colonies who have completed their Class XII, professional higher education remains a distant dream. Professional courses are expensive and scholarships offered by government and private organizations are very few. Knowing this, children do not aspire to acquire professional degrees. Instead they opt for a general B.A. or B.Sc. degree. In the current Indian context, such a degree has hardly any value in securing well-paying employment.

HHDL - Sasakawa Scholarship provides an opportunity to meritorious children from leprosy colonies to pursue higher studies and attain professional qualifications that will make them employable.

Set up as a long-term program, it aims at encouraging and motivating younger children to aspire for higher education and to work hard to qualify for admission in such courses.

In 2016-17, 15 students from Bihar, Chhattisgarh, Delhi, Jharkhand and UP were granted the scholarship for pursuing professional courses from reputed institutions.

Communication & Advocacy

Advocacy & Awareness Program

An informal Forum of like-minded and proactive group of Parliamentarians under the Convenorship of Mr Dinesh Trivedi, Mr. Madhu Gaud Yaskhi and S-ILF's Executive Director met with Mr. Anurag Thakur, Ms Anupriya Patel, Mr. Sanjay Jaiswal,

Mr. Ramesh Chandra Kaushik (Sonipat MP), Mr. Nishikant Pandey (Godda, JH) and Mr. Bhuvaneshwar Kalita (RS MP) in May 2016. This was to request their support to address the high prevalence of leprosy in the endemic districts in their respective states and to make government welfare schemes more accessible to the leprosy-affected.

In August 2016, the Forum members had a meeting to decide on the action plans for MPs to take forward "Eliminating Discrimination against Persons affected by Leprosy (EDPAL)" Bill 2015 in the then, ongoing monsoon session of the Parliament. The members present included Dr. Sanjay Jaiswal (LS-BJP), Mr. Kunwar Bhartendra Singh (LS-BJP), Mr. Baijayant Jai Panda (LS-BJD), Mr. Tarun Vijay (RS-BJP) and Mr. Trivedi.

In November 2016, Mr. Yohei Sasakawa, along with Dr. Vineeta Shanker went to meet Lok Sabha speaker, Mrs Sumitra Mahajan. Mr. Sasakawa briefed Mrs Mahajan about the situation of leprosy in India and around the world. Dr. Shanker apprised the Honourable Speaker about the Parliamentary Forum and the need to pass Elimination of Discrimination against Persons affected by Leprosy bill in India.

Empowerment Workshops

Residents of leprosy colonies are unable to access the several welfare measures offered by the governments due to lack of knowledge and awareness. S-ILF informs them of the different schemes available and helps them to identify the schemes under which they can seek support. It also trains them on writing petitions and seeking meetings with concerned officials. These workshops, conducted with help of local NGO partners, focus on building capacity of participants.

In 2016-17, S-ILF held two sets of workshops in the states of Karnataka and West Bengal. Following these workshops, representatives from seven leprosy colonies

in West Bengal met with their MLAs as well as with local authorities and submitted their petitions to them. The local media covered these meetings. Residents of eight leprosy colonies of Karnataka also met local authorities to submit petitions about problems in their colonies. For most of the colonies, this was the first time that they were seeking integration into existing schemes on their own.

Women Empowerment Program

S-ILF's experience over the last several years has demonstrated that women led or women dominated projects tend to be more successful. Despite the social and gender bias, lack of exposure and experience, women show a greater commitment and sincerity in making a success of the economic ventures. However, while contributing to the projects, women struggle to combine their traditional roles as homemakers with their project activities. For better participation in their projects they need support and build capacities.

S-ILF started the women empowerment workshops in 2015 to enable women to make informed choices in the different areas that affect their lives.

One of the sessions during Women Empowerment Workshops

S-ILF's Women Empowerment Program (WEP), provides a platform to discuss and address a wide range of personal and social issues. The aim of this program is to strengthen their capacity so that they are able to handle the multiple tasks that they have to perform in their daily lives. The program also aims to develop them as Agents of Change so that they can help other women in their colonies and in the larger community. Women identifying their challenges and strengths

In 2016-17, S-ILF conducted workshops for 28 women from 11 colonies of Bihar, Jharkhand, Maharashtra, Madhya Pradesh and Chhattisgarh. The focus of the training was effective household and relationship management, parenting, health, nutrition, water and sanitation and financial management.

The WEP has seeded the idea of the need for transformation in the colonies and created an immense buy-in among women. The results are evident in the confidence level of those women who participated and in their stories of the changes in the different aspects of their life and work.

Awareness Program

As part of the Awareness Program, S-ILF reaches out to schools and colleges, media, medical institutions, lawyers and social activists, local government institutions and employers as well as corporate houses. Participants during women Empowerment workshops in New Delhi

Though easily treatable, leprosy still strikes fear in a country like India. Lack of knowledge about the disease has led to the perpetration of misinformation and misconceptions. This is true even among the educated. The negative perception of the disease manifests itself in discrimination against and exclusion of not only the leprosy-affected but also their families. Special and concerted efforts are needed to eradicate the stigma.

Young Partners Program

With the support of National Human Right Commission (NHRC) S-ILF, has sensitized around 3,000 children from 30 government schools in Delhi. The interactive sessions have included role play, Q&A sessions and poster making competitions.

Earlier, S-ILF began its outreach to private schools in Delhi, beginning with students of Class XI and Class XII at Vasant Valley School. To raise awareness about leprosy amongst students, The Sri Ram School formed a student council which has taken up sensitizing children from other schools as well. Pathways is one of the schools where the council held an awareness session. The student council school Program also raised funds for S-ILF's education program. A play on leprosy stigma, written and enacted by these students was showcased in other private schools.

Yellow Ribbon Campaign

Yellow Ribbon is a symbol of support to end discrimination against the people affected by Leprosy.

S-ILF promoted its Yellow Ribbon campaign in all its events, workshops, talks and meetings. Without any prior experience of running a business, a group of six women from Bethel Nagar Colony, Chengalpattu came together to do retail business with S-ILF's training and financial support. Their enterprise initially started with selling 10 varieties of rice bought from the wholesale market and repackaged according to customer demands, for which they rented a room for storing and packaging. Recently, they have diversified to supplying packaged drinking water, cooking oil and clothing items. They put the clothing items also on display on the day of common community meeting in the community hall.

The group initially used their own contacts (friends and relatives) to develop their business network, and later expanded it by advertising through printed leaflets. Currently they have a regular client base and specialize in timely supply of goods to their customers in and around the colony. One of the woman beneficiaries rides a cycle and provides free home delivery. Most of the customers buy the products on credit, which sometimes becomes a hurdle. They overcome this by raising the price marginally while selling on credit. The group has learnt to keep accounts and is efficient in collecting pending payments.

The group is actively contributing to the community fund. They are aware of the competition in the market and the challenges of seasonality, which they are trying to combat by developing a risk mitigation plan with the help of S-ILF and the Project Mentor.

All group members have better facilities now and are of the opinion that added income has helped them in accelerating the construction work at home. The income from the activity is largely used for children's education. Close interactions and mutual support beyond the livelihood

activities and a strong determination has made the women's group a strong social unit. S-ILF's support has built their confidence and motivation to lead a life of dignity.

A group of seven women from Barathapuram Colony started mini tent house business with S-ILF support. The idea of renting tent house items emerged from the fact that the tent house owners used to refuse sending items in the leprosy-affected colony or charged more due to stigma. The group started by providing these items on rent at various community events, family functions on rent. For poor, the items are free and for other colony residents, they are available at cheaper rates. Unfortunately for the group, four of the members had to opt out early on from the venture and the project faced

the possibility of closure. However, the remaining three decided to continue with the enterprise.

The group meets regularly and keeps records of their transactions. They have learned to negotiate with others to maintain their financial documents, going to banks and keeping accounts in an organized manner. They support each other in every aspect of life.

As the tent house business is seasonal, the group decided to diversify and invested their profits in selling clothing items, cosmetics and other women's accessories on credit basis; this is a business that runs throughout the

year and peaks in the festive season. They keep signed records of the clients (in case of credit) to maintain accountability and transparency. The livelihood venture is earning an income for the members. They have decided to use very little of their income for their personal expenses and are using their savings for expanding their business.

They go to a well-known wholesale cloth market for buying materials, which they sell house to house. They have a committed clientele for both the livelihood ventures. They recognize and are conscious that the livelihood ventures have given them opportunity to go out of their colony and interact with people outside the colony. None of the family members of the group members are engaged in begging.

The group requested for support to start a centering project (support structures for construction site) as they were already engaged in construction work and had knowledge of the work. With S-ILF support, they learnt how to manage the finances and the accounts as well as how to use banking facilities. The group has shown remarkable progress in the two years since the start of this venture.

The group is highly motivated and members support each other in all spheres of life. The group members meet regularly to plan their business. The group members have explored and developed a good network with builders

and masonry contractors for new job contracts. The group has prepared a job list with pricing which is revised every year as per the prevailing market rates. Through this venture, all the group members have regular employment for 26-28 days a month and at times even need to hire outside labour to pitch in. Presently, each member earns about Rs.11,000-Rs.12,000 per month and gets a return on capital investment. Since centering work is risky, they take precautions such as using helmets and have insured themselves. In case of illness or injury, the group provides about 40% of the daily wage to that member.



The members have developed a strong ownership of the venture. The profit from the activity is reinvested and the group is looking for a storage space. The increased and regular income has helped them to increase their assets and invest in the education of their children. None of the family members of the group are engaged in begging.

Sanjay's family lives in Premnagar Colony which is approximately 7 kms from the Champa railway station. This colony is large big with a population of 5000-7000 leprosy-affected people from UP, Bihar, Odisha, Chattisgarh, West Bengal. The stigma against the disease is very high in this area and the colony is located outside the city. Sanjay lives with his parents who are leprosy-affected and three elder brothers are married and stay separately. Both his parents depend on begging for a livelihood. After completing his 12th standard, Sanjay did a short Diploma course in ITI Electricals offered by The Leprosy Mission. He worked as a lineman and earned about Rs.2,500 to Rs.3,000 per month for a short period of time.

When he came for a training organised by S-ILF for youth, he was trying to find something related to his diploma which would help him to improve the household income. During one of the training sessions, when participants were asked to identify the resources in

their locality

After the training I lost interest and did not want to submit my proposal as we had to do lot of work to prepare my business plan. But due to motivation from the trainers and my parents I submitted, now I realize it was the best decision I ever made.

he realised that his family owns two-acre of land and access to additional acre which is lying unutilised. He realised there is ample supply of water and ready market for vegetables since vendors would come to sell vegetable to their colony.

After first crop of vegetables, he decided to cultivate rice instead. During this time he continued to buy vegetables from weekly bazaar and sell it in his colony. Later he decided to return to growing vegetables as he saw that as more profitable. He now grows green vegetables, tomatoes, onion and other local vegetables preferred by his customers. He also supplies to people outside his colony and sells in the weekly bazaar. Both his parents help him in the field; his father also helps him in selling the vegetables.

During summer month he has to get water from the nearby river. He also has done barbed wiring to fence in few sections of his land to ward off grazing by animals. He is using traditional methods to grow vegetables and is keen to undergo training provided Krishi Vigyan Kendra (KVK) on learning advanced technology. Seeing his progress, he has become a role model for other youth in the colony.

Namrata's father contracted leprosy at the age of 20 when he developed few patches. His family advised him to get a check-up done and he was initially treated for skin disease. Later he was diagnosed with leprosy. He moved from places to place- Pune, Ahmedabad, Amravati, Jaipur for treatment with no respite. Finally, he shifted to Delhi and set up a tailoring business.

Namrata completed her schooling from the government schools in Dilshad Garden in 2015 and attended one of the briefing session on H.H. The Dalai Lama-Sasakawa Scholarship given by S-ILF. She applied for the scholarship. Based on her merit and her choice of course she was offered a scholarship. The scholarship helped her to pursue a career in aviation and she took her training for airline flight attendant from Frankfinn Institute of Airhostess, which is one of the premier institute. Namrata completed her graduation in Bachelor of Arts from Delhi University through correspondence.



Initially, Namrata could not get a job in the aviation sector, and worked in the hospitality sector for a while. In 2017, she got her dream break and was selected as a cabin crew with one of the leading airlines and would undergo training in the coming days. Her dreams have taken off a flight and souring higher and higher.

Overcoming obstacles!

Subhash hails from Himatnagar, a small village which is 60 km away from Ahmedabad. Subhash's both parents were affected by leprosy and in order to get treatment they approached an organization called Sahyog Kushtha Yagan Trust that works with leprosy-affected people. Subhash's mother was severely affected and her limbs were deformed. As his father didn't have any deformity and was jobless, so Sahyog Kushtha Yagan Trust hired him as an electrician in their organization.

Subhash lived for about 15 years in the colony and he did his schooling from a government school in Himatnagar. Due to economic constraints, Subhash could not pursue his studies further and did odd jobs at different places. Later on the Sahyog Kushtha Yagan Trust offered him a job as an attendant in their hospital. There they provided him a short duration training.

In January 2016, Pratham Education Trust, one of S-ILF's STEP-UP project partner initiated their mobilization Program in Madhya Pradesh and reached out to youth living in leprosy colonies. Subhash's father got to know that they are providing skill development training in bedside assistance training in Indore and encouraged him to undergo the training.



After completing the training in May 2016, Subhash got a job at Chaitram hospital in November'16. Initially he was offered Rs.5,000 per month, but seeing his dedication

and his performance the hospital administration increased his salary to Rs.7,000 per month within 3 months along with other staff benefits like Provident Fund, ESI and 10-15% increment every year. Prior to this training, Subhash had no idea of his future but now he is settled and doing well.

Realising a dream!

Manisha Kumari has completed her B.Sc. in Nursing with the scholarship support provided by S-ILF. She belongs to a poor leprosy family from Raxaul with five sisters and two brothers. She stayed for initial five years with her family and later in a charitable institute, Little Flower Leprosy Welfare Association (LFLWA).

She completed her 10th standard and could not continue her education, with a clear choice given by her family to either marry or work. She was not ready to get married and left her house to take up part time job in the accounts section with LFLWA while continuing her studies study.

She did not give in to her family's pressure to get married, and decided to take a loan to pursue higher education. She came across the opportunity provided under the scholarship and applied for the same.

Her application met with the selection criteria and S-ILF gave her financial support needed to enroll for course in a renowned nursing college in Karnataka. Initially she found it very difficult to adjust and felt homesick but adjusted soon and studied to stand first in her class by securing 74.5% in Rajiv Gandhi University of Health Sciences (RGUHS), Bangalore.

She is now working as a Nursing instructor in Tripolia Social Service Hospital, Patna and is currently earning Rs.15,000/- pm.

Despite All Odds

Until a few days ago, residents of Jeevan Jyoti Leprosy Colony, Yadgir were unsure of their future in the colony which had been their home since 1980. The colony was situated on 10 acres of land, given by the forest department to a trust based in Bengaluru for leprosy related activities. The trust is no longer functional, since all its members have passed away. With no one to look after the leprosy-affected persons and the remote location of their habitat, the colony, once a home to around 50 families gradually reduced to 18 families.

There was no livelihood option within the colony and those who were capable of earning a livelihood, especially the youth, had moved to cities like Hyderabad. Only the old and disabled people stayed back and most of them depended on begging for their survival. Despite these challenging circumstances, the people formed a group and decided to quit begging by opting for agriculture work.

Most of the land, behind their colony was barren, filled with wild shrubs and rubble. The residents cleared some of this land to start cultivation despite deformities and meagre resources.

With training and financial assistance from S-ILF, they installed water submersible pump, agricultural tools and sowed their first crop. But much before cultivation, crops were destroyed by stray cattle as their field had no protective fencing. They did not let this deter them and decided to start again but repeated theft of tools and utilities thwarted all their plans.

They approached the District Collector with request for fencing but were informed that the land does not belong to them but to a Trust. This came as a blow and pushed them to find a permanent solution. S-ILF stepped in to help a delegation from this colony.

The Community members persisted until their efforts bore fruit. The District Authority finally allotted them more than one acre of land to be used for housing and cultivation. Recently, construction of a new road connecting their colony to the town has started. Solar power generated is lighting up the houses and soon their demand for fencing will be provided for their whole colony including the agricultural patch. Jeevan Jyoti Leprosy Colony, Yadgir is seeing reverse migration, proof of the fact that life is changing course and changing course for the better.

Residents were invited to participate in empowerment workshops organized by S-ILF across seven leprosy colonies of North Karnataka. There they learnt about different government schemes and how to avail them. This included writing applications, petitions and meeting government officials. After two workshops, they felt empowered to meet District Officials along with their state leader, Mr. Hanumantha Devnoor. This was followed by a meeting with the MLA.

Association of People affected by Leprosy (APAL)

Association of People affected by Leprosy (APAL) is a national networking organization of people affected by leprosy. Founded in 2006 with active encouragement and help from the Nippon Foundation, Japan, it is an essential part of Mr. Sasakawa's vision of mainstreaming the affected population and their families thereby restoring their dignity.

APAL provides a platform where people affected by leprosy can discuss their issues and take up matters relating to their rights and entitlements at various levels of State and

Central Government if required. For e.g. issues pertaining to their land rights, pensions, and specific schemes for disabled people, human rights issues, education & employment, housing, sanitation, etc.

The first President of APAL was Dr. P.K. Gopal. Few years ago, this important responsibility was handed over to Mr. Narasappa. Several years ago, APAL conducted a survey of colonies in India and identified around 800 selfsettled colonies.

Currently APAL has their head office in Hyderabad and the leaders (both nominated & elected depending upon the need & situation) have their respective state forum to address the issues of their communities.



S-ILF works with State/Regional Leaders of APAL to identify the potential colonies/beneficiaries in need of support for the livelihood projects as well as education & advocacy programs.

Over the years, S-ILF has worked in close collaboration with APAL to strengthen its program. This, has led to increased trust and rapport between the two institutions. There has been steady and positive progress in S-ILF's relationship with APAL as some leaders have helped immensely in flagging off real concerns/challenges during program implementation. Therefore, keeping this in view, S-ILF has started appointing few of such Leaders as Mentors/Facilitators for implementing the livelihood projects.

Global Appeal 2017: To end stigma and discrimination against people affected by leprosy

Every year, in conjunction with World Leprosy Day on the last Sunday in January, Mr. Yohei

Sasakawa, Chairman of The Nippon Foundation, WHO Goodwill Ambassador for Leprosy Elimination and Japanese Government Goodwill Ambassador for the Human Rights of People Affected by Leprosy, leads a Global appeal to end stigma and discrimination against people affected by leprosy.

Due to severe visible deformities, leprosy was feared for many centuries as a contagious disease. However, in the 1980s, discovery of multidrug therapy ensured, that if the treatment was given in time, the disease could be cured without any visible physical side



² The Inter-Parliamentary Union is the international organisation of Parliaments, established in 1889. The Union is the focal point for World-wide parliamentary dialogue and works for peace and cooperation among people and for the firm establishment of representative democracy. Speaking about the 'Global Appeal' Summit, Dr. Vineeta Shankar, Executive Director of Sasakawa-India Leprosy Foundation said:

"As leprosy is completely curable, timely detection is imperative. Nonetheless, mass awareness is important to ensure age-old stigma and myths do not prevent leprosy-affected persons from learning employable skills. The Summit is part of the ongoing efforts to make the world a better place for such people."

effects. Further, as leprosy has a very low rate of infection, 16 million people have recovered from this disease since multidrug therapy began.

Elimination of leprosy as a public health problem is defined by the WHO as a prevalence of less than 1 person affected per 10,000 of the population. India achieved the target in 2005. In 1985, 122 countries had not achieved elimination, whereas currently there is only one country left (Brazil), which is yet to meet the target.

From a medical aspect, leprosy issues are moving toward being resolved; however, from a social point of view, stigma and discrimination against people affected by leprosy is still deeply rooted in. Across the world, correct information pertaining to leprosy is not widely known, which leads to delayed medical attention and to societal discrimination. Due to this discrimination, individuals who have

recovered from leprosy and even their family members cannot obtain work, get married, or receive an education. They are forced to exist on the margins of society.

The Global Appeal is designed to raise awareness in society by providing correct information about leprosy, including that it is curable disease with free treatment available and that discrimination is unjustifiable. The first Global Appeal was held in 2006.

The Global Appeal 2017 was launched on January 30, 2017 in Delhi, India. As endorsed by its Executive Committee, the Inter-Parliamentary Union (IPU), the world organization of national parliaments, strongly supported this Global Appeal.
